NEIGHBORHOOD HISTORY 1965

The bombing of Dr. Reginald Hawkins' home in November 1965 was a pivotal moment in the history of Charlotte, North Carolina. Dr. Hawkins, a prominent civil rights activist. had been leading efforts to desegregate schools, hospitals, and restaurants in the city. His house was bombed in the middle of the night by an unknown assailant, but the McCrorey Heights community rallied around him and his family in a show of support and solidarity.

Despite the attack. Hawkins continued to fight for civil rights in Charlotte and across North Carolina. He ran for governor in 1968, becoming the first African American to seek the office in the state's history. Though he did not win the election. he continued to be a vocal advocate for equality and justice until his death in 2007. Today, residents of Charlotte still remember the bombing and the community's response, a testament to the resilience and determination of those who fought for civil rights in the city.



HISTORIC DESIGNATION COMMISSION REPORT

In the City of Charlotte, project applications to various boards generally have fees for submission associated with them. This is true for the Historic District Commission (HDC). And, in 2022, City Council added 'After-the-Fact' fees to project application submissions to encourage people to talk with the HDC before starting a project.

So, what is an 'After-the-Fact' project? A project is considered 'After-the-Fact' when it is ongoing or completed without prior approval from the HDC, meaning that the project wasn't reviewed and approved prior to the start of the work and no Certificate of Appropriateness (COA) was issued. An 'After-the-Fact' project adds time and money to the project for both the applicant and the HDC. Additionally, in some cases if the work (that is already in process or finished) is determined to not comply with the Charlotte Historic District Design Standards, then that work will be required to be corrected and/or removed.

Below is the current HDC fee schedule:

Project	Fee	Description
Administrative Review	N/A	See page 2.6 of the HDC Design Standards
Administrative Review, After-the-Fact (work done without pre-approval)	\$350	See page 2.6 of the HDC Design Standard
Minor Review (including After-the-Fact applications)	\$840	 Additions of any size to structures located on corner lots. Accessory structures visible from public-rights-of way, such as garages on corner lots.
Major Review (including After-the-Fact applications)	\$1300	 Additions that increase the square footage of the principal structure by 50% or more. Painting previously unpainted masonry. New construction of principal structures.
Demolition	\$2,500	Demolition of primary structures

HISTORIC DESIGNATION COMMISSION REPORT

Basically, administrative (staff) review cases have no application fee. But, if it's an After-the-Fact case for administrative review, then the fee is \$350. Please note that many projects can be reviewed by the HDC staff versus going to the Full Commission for review, and if the application for staff review is submitted and reviewed **before** the work has started, then there is no application fee. Once an application is submitted and processed through our system, then Staff will let the applicant know via email if a fee is required and the amount.

We strongly encourage applicants to contact the HDC staff prior to the start of a project – even if it's in the backyard or interior or seemingly minor.
